This entry-level position provides the opportunity for a candidate with technical, energy efficiency or building science experience or interest to enhance skills and expertise in building science principles.

Tasks may include working closely with program partners, trade allies, customers and internal team members to conduct and/or support residential weatherization field inspections, review building findings, compile reports and analysis, and work with our partners to identify and implement solutions. The Technical Program Coordinator may attend technical trainings to seek relevant certifications and credentialing. This role may additionally perform a range of tasks to support the programs in achieving energy savings goals. Tasks may include using program systems and procedures to assess and verify project eligibility, track and report project milestones, assist with customer and partner communications, track budgets, and other internal projects as needed.
