About the Jon Siemen Memorial Scholarship

Overview of Jon's Career

The Jon Siemen Memorial Scholarship has been developed to honor the life, memory, and work of Jon Siemen, who passed away in March 2015. Jon started his career in weatherization in the late 1970s, when he began working at Community Action in Southwestern Vermont (BROC). Around 1993/1994, Jon and his brother started an air sealing service that they ran for a few years.

In 1996, Jon joined the Champlain Valley Office of Economic Opportunity (CVOEO) and oversaw their field office, located in Middlebury, VT. In 2001, he left CVOEO and became a weatherization director for a succession of NYS weatherization programs, for Washington, Warren, and Hamilton Counties.

His Time at BPI

Jon began working at BPI in 2009. While with BPI, he filled the roles of Field Representative and Technical Relations Representative. Over the years, Jon was involved in administering BPI exams, contributing to standards and certification development, performing quality assurance reviews, and answering technical questions presented by contractors, candidates, and proctors.

Jon was a beloved member of the BPI staff and could always brighten your day with his quick wit and sense of humor. He loved sharing stories about his family, dogs, hunting, tapping trees for sap, and his Italian heritage. Jon made an impact on the industry, on the lives of those he helped through home performance, and on the lives of those he worked with.

Purpose of the Scholarship

The Jon Siemen Memorial Scholarship is intended to help individuals in the industry who are working to make a difference in the comfort, health, safety, and energy efficiency of our homes. Jon had a passion for weatherization and helping others. In turn, this scholarship program can help others who have a passion for weatherization.

What It Covers

The Building Performance Institute, Inc. will be awarding this scholarship to four recipients annually.

Recipients of the scholarship will be able to take the online and field exams that are applicable for the certification designation indicated on the application, at no cost. BPI will also work with each recipient, in an effort to help them obtain training for that certification, possibly at reduced or no cost. The scholarship covers one attempt at each exam. The scholarship does not cover retakes if a recipient is unsuccessful on either or both exams.

The exams must be taken by the end of the calendar year in which the scholarship is awarded, to be covered by BPI. Scholarships cannot be rolled over to subsequent years. BPI will help arrange testing with a BPI Test Center that is approved to administer the applicable exams.

If the individual receiving the scholarship has indicated on their application that they would like the scholarship to be applied to one of the certificate programs, that recipient will receive a copy of the appropriate Reference Guide, for BSP or HHP, or access to the training module for SSC. They will also be able to take the BSP, HHP, or SSC exam at no cost. The scholarship will cover one attempt of the exam, which must be taken by the end of the calendar year in which the scholarship is awarded.

Applying for the Jon Siemen Memorial Scholarship

When to Apply

Applications can be submitted year-round. Applications submitted through November 30th of any given year will apply toward the subsequent year's scholarship. Any applications received after November 30th will be held and applied toward the following scholarship year. For example, an individual who submits the scholarship application between December 1, 2022 and November 30, 2023 will be applying for the 2024 scholarship, which will be announced in March of 2024. An individual who applies in December of 2023 has missed the deadline for 2024, and will be applying for the 2025 scholarship.



Who Should Apply

To be eligible for the Jon Siemen Memorial Scholarship, an individual must currently work with a weatherization assistance program or they must be a United States military veteran. This scholarship cannot be used to renew a BPI certification or reobtain an expired certification. This scholarship cannot be used to obtain the Building Science Principles (BSP) or Healthy Housing Principles (HHP) Reference Guides, the Site Supervisor Certificate (SSC) training, or take the BSP, HHP, or SSC exam, if the individual has already obtained that specific certificate in the past.

Multiple BPI certifications, as well as the Site Supervisor Certificate (SSC) have prerequisites that must be met for an individual to be approved to take the exam(s). Refer to the appropriate certification or certificate scheme handbook for details on prerequisites. Individuals who do not meet the prerequisites are not eligible to receive the scholarship for those designations.

Individuals can only receive this scholarship one time. If you previously received the Jon Siemen Memorial Scholarship, you are not eligible to receive the scholarship again, for any designation.



Steps to Apply for the Jon Siemen Memorial Scholarship

Instructions for Applying

Before submitting this application, you will need to review the scheme handbook that applies to the certification designation you have indicated on the application. The certification and certificate scheme handbooks contain important information about the certifications, certificate, and/or exams. They can be found at bpi.org/certified-professionals or www.bpi.org/sitesupervisorcertificate.

If you are looking to receive the scholarship for the AC/Heat Pump Professional, Building Analyst Professional, Building Analyst Technician, Crew Leader, Energy Auditor, Quality Control Inspector, Retrofit Installer Technician, Healthy Home Evaluator, or Site Supervisor Certificate, you must meet the prerequisites for the certification/certificate you have indicated on the application and must be able to supply documentation showing that you meet the prerequisites.

Please complete this application in its entirety. Any sections marked optional do not have to be completed, but they will be used to help determine the scholarship recipients. If you need additional space to complete the items in the experience section, please use a separate sheet of paper and attach it to your completed application.

The recipients of the Jon Siemen Memorial Scholarship will be chosen at BPI’s discretion, based on the scholarship application and any accompanying documents that are submitted.
