### **JOB SUMMARY:**

We are seeking a detail-oriented and skilled Certified Energy Auditor to join our team. The ideal candidate will be responsible for evaluating the energy usage and efficiency of buildings and systems, recommending improvements, and ensuring compliance with energy standards for residential customers within the assigned New Jersey counties. The Certified Energy Auditor will work closely with residential clients to assess their energy consumption, identify inefficiencies, and provide cost-effective solutions for energy conservation. This position requires travel within the PSE&G New Jersey service territory.

### **KEY RESPONSIBILITIES:**

- Conduct on-site energy audits of residential and multifamily units (up to 8 units), to evaluate energy consumption patterns and systems.
- Perform assessments of heating, ventilation, and air conditioning (HVAC) systems, lighting, insulation, and other energy systems.
- Utilize specialized equipment (such as infrared thermography, blower doors, and energy monitoring tools) to identify energy inefficiencies and potential areas for improvement.
- Analyze utility bills and other data to develop an accurate energy profile of the building or facility.
- Prepare comprehensive energy audit reports outlining findings, including energy-saving opportunities and associated cost savings.
- Provide recommendations for energy-efficient upgrades, improvements, and retrofits.
- Ensure compliance with local, state, and national energy regulations and standards.
- Collaborate with clients to develop and implement energy conservation strategies that align with their sustainability goals.
