- Directs the work of all employees assigned to the program from technical, marketing, operations, analytics and administrative areas
- Evaluates performance, makes recommendations and implements decisions related to program actions
- Establishes milestones and monitors adherence to project plans and schedules
- Leads marketing strategy and overall efforts to support program production goals
- Identifies obstacles, recommend and implement solutions to ensure project success
- Coordinate the preparation of new and pre-existing business plans, work statements and specifications, operating budgets and financial terms/conditions of contract
- Act as the point of contact for utility client inquiries and requests
- Attend client meetings, lead program planning and performance discussions and presentations
- Direct and coordinate multi-function teams typically consisting of 10-40 people
- Direct people management, with span of control for 4-8 people, plus contractors
